This letter and the enclosed Katie Beckett application packet for Medical Assistance have been sent to you as you requested or at the request of someone else on your behalf.

The Executive Office of Health & Human Services (EOHHS) provides Medical Assistance through the Katie Beckett coverage group to children with disabilities living at home who also require the level of care and services provided in a medical or psychiatric hospital, a nursing facility or an Intermediate Care Facility for the Mentally Retarded (ICF/MR) group home (which serves children with developmental disabilities).

The Katie Beckett Unit processes all new Katie Beckett applications and annual re-determinations. Staff are available to assist with the application process and to answer questions about RI Medicaid-covered services, eligibility, and other EOHHS Programs.

Carla Russo, a parent consultant, has recently joined our team. Carla is a parent of a child who has had Katie Beckett coverage. She is available to answer your Katie Beckett questions and to help parents understand how Katie Beckett coverage can help their child and family. Carla can be reached at 401-462-0633. Please complete the enclosed application forms, making certain to sign each form that requires a parent or guardian signature. If you should have questions or need assistance in completing these forms, please contact our parent consultant (401-462-0633) or your child's Social Case Worker:

If your child's last name begins with  $\mathbf{A} - \mathbf{M}$ , call Caridad Ramos at (401) 462-0760. If your child's last name begins with  $\mathbf{N} - \mathbf{Z}$ , call Ann Murphy (401) 462-0754.

You are encouraged to submit copies of recent clinical evaluations (examples: Medical, Behavioral, Physical, Occupational and Speech/Language) with your application. If more clinical information is necessary to determine disability or level of care, you will receive a letter informing you of what specific clinical information is needed. This request may include recent Early Intervention or school evaluations, hospital discharge summaries, or medical and behavioral health specialty evaluations.

Katie Beckett eligibility decisions must be made within ninety (90) days of the date EOHHS receives the application. Recent clinical information helps our clinical reviewers make eligibility decisions accurately and promptly. Copies of medical release forms are enclosed for your use, as providers are required to have signed medical releases before sending information to the Katie Beckett Unit.
