Custom Medicaid AE/MCO report on quality measures completed and will be reviewed with AEs/MCOs Additional sites being onboarded for Prospect and Integra. Analysis framework/process being developed for site compliance into USCDI requirements.

EHR Integration (NextGen) with BVCHC in process. Training of DHS-Refugee Assistance program staff on Unite Us platform underway. Training of DCYF Support and Response Unit (SRU) staff on Unite Us platform underway. Overview/demonstration of the Unite Us platform was conducted to the CCBHC Learning Collaborative. Over 439 organizations, with a total of 1,040 programs, are now part of the Unite RI network.
