Maintenance Information

Sandata will deploy this update to the system on Thursday, April 11, 2019 at 9:00PM Eastern Time (ET). The maintenance will take 4 (four) hours, ending at 1:00 AM ET on Friday, April 12, 2019. Please advise your staff to log out of the system by 9:00 PM (ET) on Thursday, April 11, 2019. Failure to log out of the system may result in the user being automatically timed out.

During this time:

- The system will be unavailable.
- Field Staff who call in and call out, should continue to call in and call out.
- Field Staff, using Mobile Visit Verification (MVV) on a mobile device, will be able to log in or out using the device.
- Calls will continue to be collected, but they will not be sent to the agency databases until the maintenance is complete.
- There will be alerts sent during the time the system is down.
