The Rhode Island Executive Office of Health and Human Services (EOHHS) is advertising the following change:

Intellectual and Developmental Disabilities (I/DD) Service Rates

The FY 2020 Appropriations Act, enacted July 1, 2019, directed EOHHS to increase the rates for certain I/DD Direct Service Providers and self-directed consumers to support an increase in direct service staff wages and associated payroll costs. The services that will be affected are as follows:

- Residential Habilitation
- Independent Living/Family Supports
- Transportation
- Prevocational Training
- Supported Employment
- Day Programs

This change will result in an increase in annual expenditures of approximately \$9.5 million all funds for State Fiscal Year (SFY) 2020. The effective date of this change is October 1, 2019.

A request for an oral hearing must be made within thirty (30) days of this notice.
