### Introduction

This report is responsive to the statutory requirement in § 40-8.4-18 to release a "public health access beneficiary employer report" that provides information on each employer with at least 50 employees on Rhode Island State Medicaid. Specifically, the statute stipulates:

"The department of human services shall annually prepare a public health access beneficiary employer report. A 'public health access program beneficiary' means any person who receives medical benefits from RIte Care, RIte Share, or Medicaid. Any applicant for public health benefits through RIte-Care, RIte Share, and/or Medicaid shall identify the employer or the employers of the proposed beneficiary of the health care benefits. The report shall provide the following information for each employer of fifty (50) or more public health access beneficiaries:

- (1) the name and address of the employer;
- (2) the number of public health access program beneficiaries who are employees of the employer;
- (3) the number of public health access program beneficiaries who are spouses or dependents of employees of the employer;
- (4) whether the employer offers health benefits to its employees;
- (5) whether the employer participates in the RIte Share program; and
- (6) the cost to the state of Rhode Island for providing public health access benefits to their employees and enrolled dependents.

In determining whether the fifty (50) employee threshold is met, the department of human services shall include all public health access program beneficiaries employed by the employer and their subsidiaries throughout the state. The report shall not include the names of any individual public health access program beneficiaries and shall be subject to privacy standards pursuant to Public Law 104-91, and the Health Insurance Portability and Accountability Act of 1996. The report shall be submitted annually on the third Tuesday in January to the joint committee on health care oversight, the house finance committee, and the senate finance committee."

This report is organized as follows:

- Employers meeting the reporting requirement, with the number of public health access beneficiaries for each such employer § 40-8.4-18 (1) through (5)
- Estimated cost to the State of providing public health benefits to beneficiaries employed at employers meeting the reporting requirement § 40-8.4-18 (6)

## Employers with at least 50 employees on RI Medicaid

Table 1 lists the employers that had at least 50 employees on Medicaid in the second quarter of calendar year 2018 (April through June 2018). The analysis that supports this list matched employer-reported data with Medicaid data. Out of confidentiality, Table 1 includes ranges of the number of employees on Medicaid by company, instead of exact counts.

It is important to note that even if an employer offers health insurance, coverage benefits vary significantly and may be available only at certain times or be affordable only for certain employees. All employees on Medicaid regardless of coverage type were counted. Employees who were not on Medicaid for the full quarter (i.e., receiving Medicaid for every day between April 1<sup>st</sup>, 2018 and June 30<sup>th</sup>, 2018) were excluded from the analysis. This decision was made because wage data is reported quarterly, with no more granular information about when in the quarter wages were paid, so the full quarter requirement guarantees that the employee was on Medicaid at the same time they were employed.

As dictated by statute, an employer with 49 or fewer employees on Medicaid, given the above methodology, is not included on this list. For the employers with 50 or more employees on Medicaid in the second quarter of calendar year 2018, Table 1 offers the following information.

- The address column reflects the employer's address, based on data from the Department of Labor and Training.
- The "Offers health insurance?" column reflects if the employer reported to the Executive Office of Health and Human Services in 2018 that they offer health insurance to at least some of their employees. A "Y" indicates that they do, and a "N" indicates that they do not. Note that a "Y" means they offer health insurance to some, not necessarily all, of their employees. "U" indicates that it's unknown whether they offer health insurance (i.e., they did not report either way to the Executive Office of Health and Human Services).
- The "Has RIte Share plan?" column reflects whether or not Medicaid has determined that an employer offers a health insurance plan that meets the Medicaid cost and benefit requirements necessary to qualify for RIte Share. A "Y" indicates that they have, and a "N" indicates that they have not. An asterisk indicates that they have a plan that is currently being processed.
- The "employees on Medicaid" column reflects the range in which the count of employees on Medicaid falls. Note that employees that were enrolled in Medicaid for every day in the quarter are counted, and the ranges used are: 50-100, 101-200, 201-300, and >300.
- The "dependents on Medicaid" column reflects the range in which the count of dependents of the employees on Medicaid falls. The ranges used are: 0-100, 101-200, 201-300, and >300
