Summary of Rulemaking Action:

This amendment definesthe provider types that are considered high, moderate, and limited risk. TheFY2023 Budget as Enacted directed EOHHS to define these risk categories, whichis also required by the Centers for Medicare and Medicaid Services (CMS). Highrisk providers will now be required to submit to a national criminal backgroundcheck supported by fingerprints as required by federal program integrityregulations. This amendment also requires caregivers to submit to a nationalcriminal background check supported by fingerprints prior to providing care to elderlyand disabled individuals without the presence of other employees, as requiredby R.I. Gen. Laws § 42-7.2-18.3. This applies to caregivers in the sharedliving and self-directed programs. The amendment also defines the criteria forqualified providers and the bases for rejection or termination to ensure thatthis information is clearly stated to existing and prospective Medicaidproviders.
