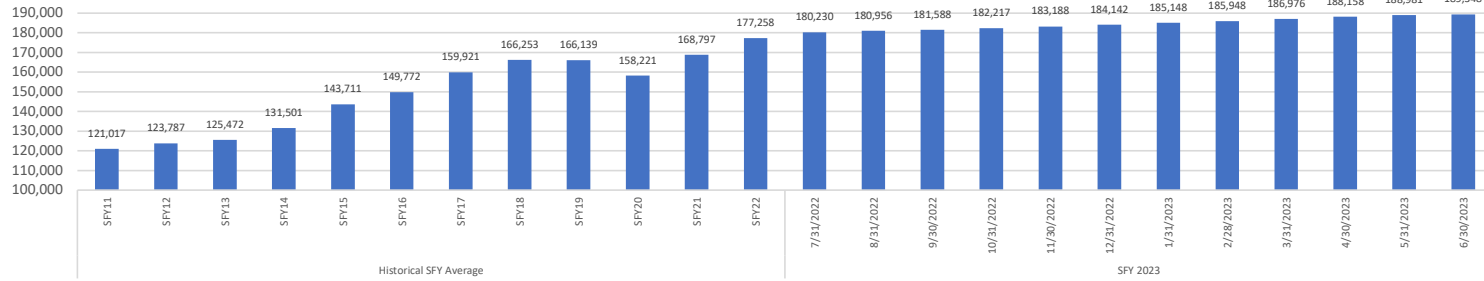

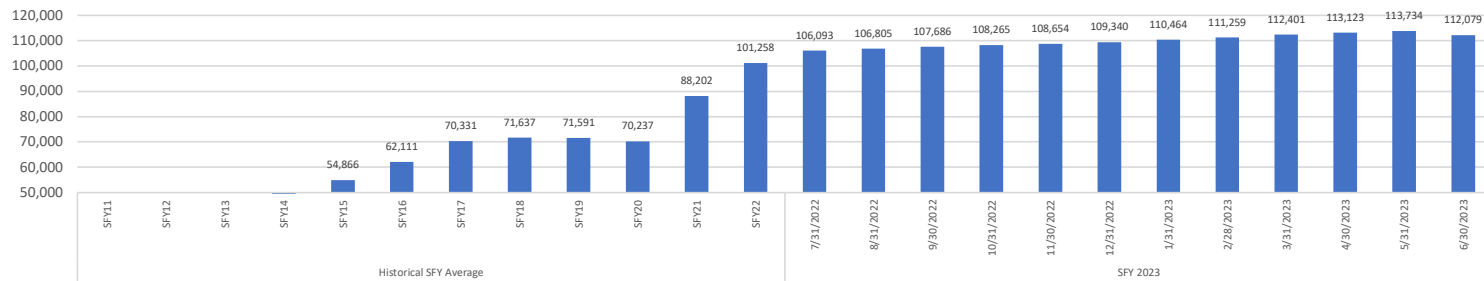

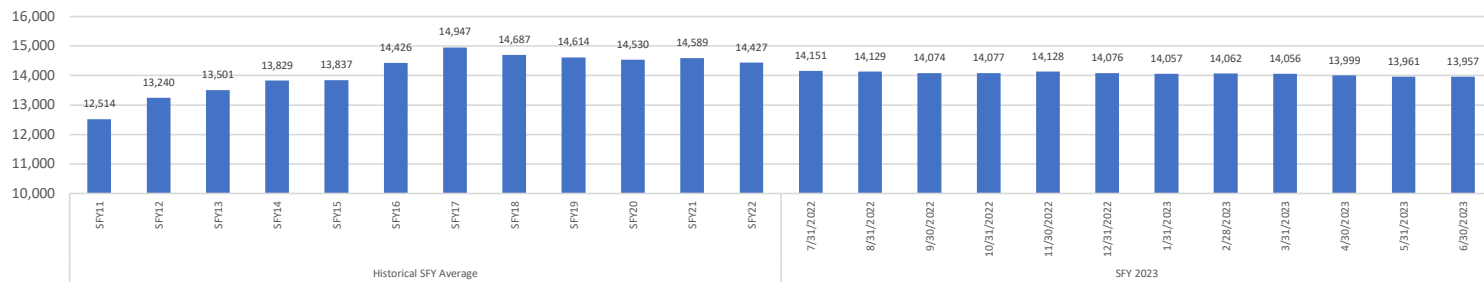
Rite Care (inc. Core/CSHCN) Managed Care Enrollment



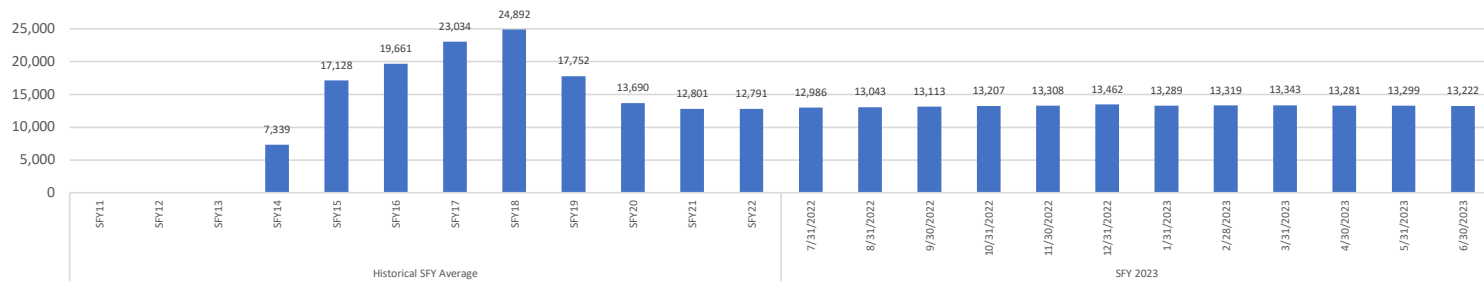
Expansion Managed Care Enrollment
