- NEW AUTH DIAGNOSIS CODE FIELD ADDED.**  
Added a new *Auth Diagnosis Code:* field to the *Authorizations* screen on a client's Electronic Health Record (EHR). This field displays the diagnosis code imported from the authorization feed only if sent via interface. The authorization diagnosis code is added to the primary diagnosis code field on the client's EHR only if there is not an existing primary diagnosis code and it does not override an existing primary diagnosis code. The field is grayed out if a diagnosis is not required.

**2. AUTHORIZATION DIAGNOSIS CODE ADDED TO THE 837 FILE.**

Updated the VNS Choice Program billing format to include the authorization's diagnosis code from the third-party interface feed to the 837 file.

**3. UNKNOWN INVOICE UPDATE.**

The remittance file now includes service date details for clients with status of Unknown to assist users in identifying payment data. Invoices with an unknown status now display, the Invoice Number and the Service Dates in the remittance file to assist the user to find the invoice and adjudicate the payment.
